

**ORDINANCE NO. 32-16**

**AN ORDINANCE TO AMEND CHAPTER §210.01 (e)(6A) OF THE CODIFIED ORDINANCES OF THE CITY OF AVON TO ESTABLISH FEES FOR THE USE OF THE CITY'S AQUATIC CENTER AND DECLARING AN EMERGENCY**

**WHEREAS**, the City's Aquatic Center will open for its first full season in 2016; and

**WHEREAS**, Council and the Administration, having set the initial permit fees in 2015 to reflect adjustments for the late opening of the facility, now find it necessary to adjust fees to reflect the anticipated full scale operations beginning in 2016; and

**WHEREAS**, Section 210.01(e)(6A) requires amendment to reflect the new permit fees to be established for 2016; and

**WHEREAS**, Council, after discussions with the Administration and careful review and analysis of pool operations in 2015, deems it in the best interests of the health, safety and welfare of the community that new permit fees for the use of the City's Aquatic Center be adopted.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN, AND STATE OF OHIO:**

Section 1 - That Section 210.01(e)(6A)(D) which currently reads as follows:

Section 2 - The codifier is hereby instructed to insert the amendments into the Codified Ordinances of the City of Avon as set forth herein.

Section 3 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Section 210.01(e)(6A)(D) to

establish fees for the use of the Aquatic Center in the City of Avon; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
