

ORDINANCE NO. 90-25

**AN ORDINANCE DESIGNATING PARK LANDS LOCATED AT
36265 DETROIT ROAD AS THE "EVERY CHILD'S PLAYGROUND"
AND DECLARING AN EMERGENCY**

WHEREAS, the City of Avon's Aquatic Center is located on approximately 20 acres of land located at 36265 Detroit Road; and

WHEREAS, an area informally known as "Every Child's Playground" is located just east/southeast of the Aquatic Center; and

WHEREAS, pursuant to Ordinance No. 84-25, which passed on September 22, 2025, Council authorized the Mayor to enter into a contract to purchase playground equipment for this area; and

WHEREAS, Council and the Administration now agree to officially name this designated area as "Every Child's Playground" and finds that doing so is in the best interests of the health, safety, and welfare of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the playground area located just east/southeast of the Aquatic Center located at 36265 Detroit Road is hereby designated and officially named "Every Child's Playground" (See attached Exhibit A)

Section 2 - That all references to this park land, including, but not limited to, maps and all other official documents, shall bear the designation, identification and name: "Every Child's Playground". The Codifier shall insert this designation into the Avon Codified Ordinances as Section 1064.07.

Section 3 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Ordinance were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4 - That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to officially declare and name the property referenced herein as the "Every Child's Playground"; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

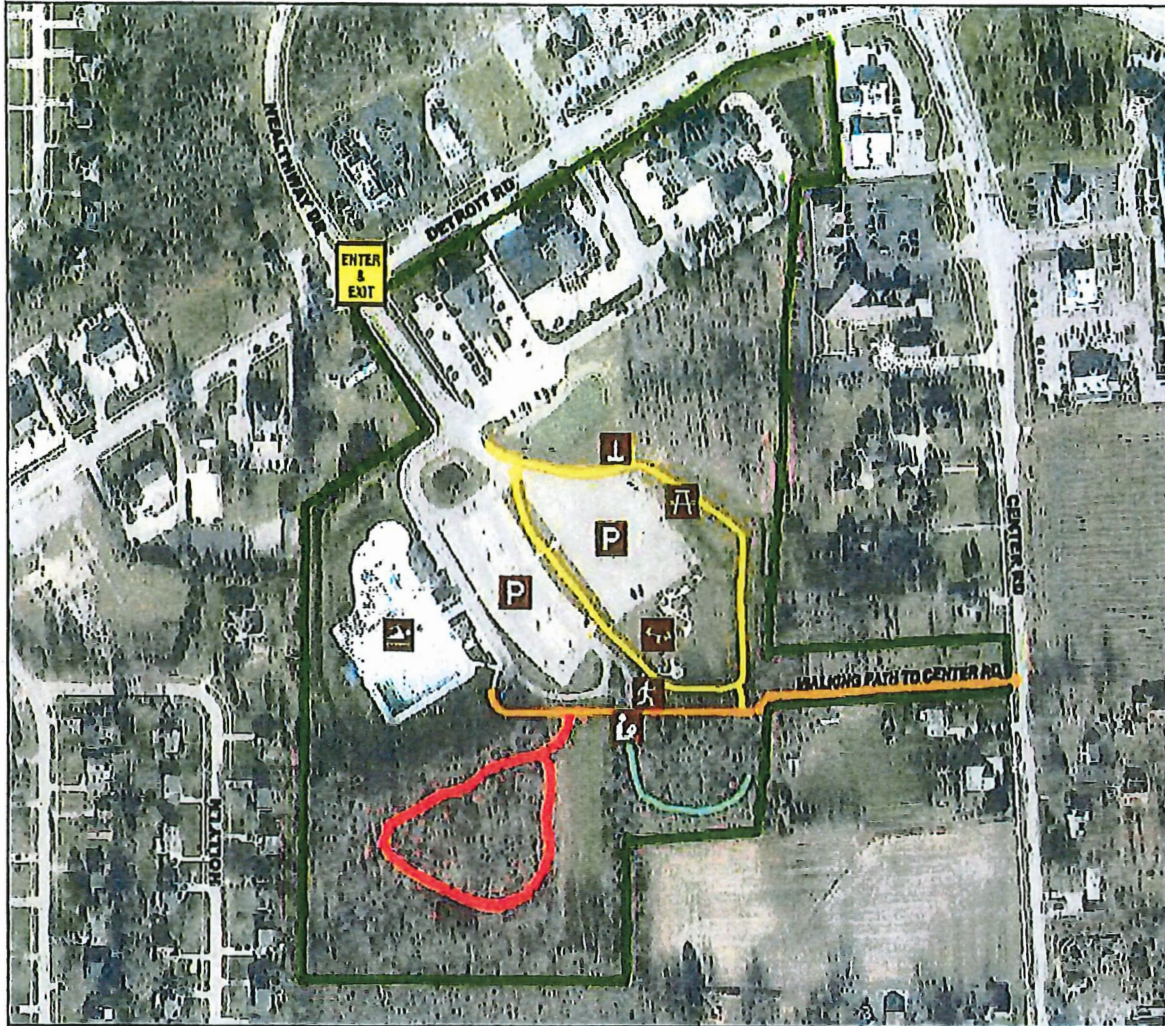

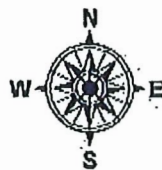


EVERY CHILD'S PLAYGROUND 36265 Detroit Rd
