

ORDINANCE NO. 49-26

**AN ORDINANCE AMENDING §256.04 OF THE CODIFIED ORDINANCES
OF THE CITY OF AVON TO RECLASSIFY THE FULL-TIME
POSITION OF RECREATION COORDINATOR
AND DECLARING AN EMERGENCY**

WHEREAS, the Administration, in reviewing the ACO Section 256.04 discovered an error pertaining to the position of Recreation Coordinator. It is currently listed as “unclassified, part-time employee;” and

WHEREAS, to accomplish this reclassification, it is necessary to amend §256.04 of the Codified Ordinances to identify the position as “unclassified, full-time employee”; and

WHEREAS, after reviewing the proposed amendment to §256.04, together with the recommendations of the Administration, Council finds adoption of the amendment to be reasonable and in the best interests of the health, safety, and welfare of the citizens of Avon.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That Section 256.04 which currently reads (in part) as follows:

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 - That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to reclassify the position of Recreation Coordinator; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

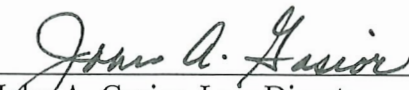

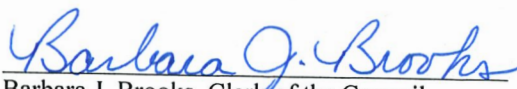
