

RESOLUTION NO. R-13-26

**A RESOLUTION TO ADVERTISE FOR BIDS FOR THE
MILLS ROAD RESURFACING PROJECT
AND DECLARING AN EMERGENCY**

WHEREAS, to address pavement maintenance conditions and to maintain a safe travel corridor it is necessary to repair and re-pave the portion of Mills Road under the City of Avon's maintenance responsibility during the 2026 construction season; and

WHEREAS, the portion of Mills Road under City of Avon maintenance responsibility is defined as the section of roadway, both the north and south sides, beginning at a point equal distant between the Jaycox Road South intersection and the Jaycox Road North intersection thence east to the Westlake Municipal Boundary; and

WHEREAS, the Avon City Engineer has identified a Mills Road Resurfacing Project which shall include the following: asphalt resurfacing without any additional roadway widening; asphalt pavement planing; placement of a new asphalt pavement surface; partial & full depth pavement repairs; utility structure rim adjustments; curb ramp replacements; pavement markings; and appurtenances thereto; and

WHEREAS, the Avon City Council finds that it is in the best interest of the health, safety and welfare of the City of Avon, its residents, and the travelling public to proceed with advertising for public bids for the Mills Road Resurfacing Project as described herein so to substantially complete the project during the 2026 construction season.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON, COUNTY OF LORAIN AND STATE OF OHIO:

Section 1 - That the Clerk of Council is hereby authorized and directed to advertise for public bids for the completion of the work items which shall include resurfacing without widening of Mills Road in its entirety from a point equal distant between the Jaycox Road South intersection and the Jaycox Road North intersection thence east to the Westlake Municipal Boundary; asphalt pavement planing; asphalt resurfacing with a 3-inch asphalt pavement; partial & full depth pavement repairs; utility adjustments; curb ramp replacements; pavement striping; and appurtenances thereto at locations determined by the City Engineer. These improvements shall be made pursuant to plans and specifications developed by the City Engineer and Chagrin Valley Engineering, Ltd., which shall be on file and open for inspection at the Office of the Clerk of Council and incorporated herein by reference.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3- That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Resolution No. 13-26 (Con't)

Section 4- That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for the Mills Road Resurfacing Project to the extent set forth in Section 1, above, in order to facilitate substantial completion prior to the end of 2026 construction season; therefore, this resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
