

ORDINANCE NO. 47-13

**AN ORDINANCE APPROVING THE NORTHEAST OHIO AREAWIDE
COORDINATING AGENCY'S (NOACA) MODIFICATION OF
THE CLEAN WATER 2000 PLAN AS THAT MODIFICATION
AFFECTS THE CITY'S SANITARY SEWER MASTER PLAN**

WHEREAS, the Northeast Ohio Areawide Coordinating Agency (NOACA), by Resolution No. 2013-02 passed January 11, 2013, modified the *Clean Water 2000 Plan*, a.k.a. "The 208 Plan", to remove an area of Avon in the northeast corner of the City from the French Creek Facility Planning Area (FPA) to the Avon Lake Facility Planning Area (FPA); and

WHEREAS, this amendment to the *Clean Water 2000 Plan* necessitates a modification of the City's Master Sanitary Sewer Plan; and

WHEREAS, Planning Commission for the City of Avon held a public hearing on March 20th, 2013, heard recommendations from the City Engineer and Utilities Superintendent, and by a vote of Five (5) to Zero (0), approved the application to modify the Sanitary Sewer Master Sewer Plan to coincide with the changes to the *Clean Water 2000 Plan* (The 208 Plan) as set forth in NOACA Resolution 2013-002; and

WHEREAS, Council, on April 8, 2013, authorized a Public Hearing; and

WHEREAS, said Public Hearing was duly publicized according to law and was held on May 13, 2013 at 6:55 PM; and

WHEREAS, Council finds that the recommended revision to the City's Sanitary Sewer Master Plan is reasonable and in the best interests of the safety, health and welfare of the citizens of Avon.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1 - That the Sanitary Sewer Master Plan for the City of Avon is hereby amended to adopt the modification to the *Clean Water 2000 Plan*, i.e., the 208 Plan, enacted by the Northeast Ohio Areawide Coordinating Agency (NOACA) in Resolution No. 2013-002 which is set forth in the attached Exhibit A and incorporated herein by this reference.

Section 2 - That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
