

RESOLUTION NO. R-10-19

A RESOLUTION TO ADVERTISE FOR BIDS FOR THE IMPROVEMENT OF CHESTER ROAD BETWEEN STATE ROUTE 83 AND AMERICAN WAY AND DECLARING AN EMERGENCY

WHEREAS, the increase of traffic volumes and anticipated future development have necessitated the widening of the roadway corridor along Chester Road west of State Route 83 during the 2019 construction season; and

WHEREAS, the existing roadway corridor varies from three lanes at the American Way intersection to two lanes and then up to four lanes at the State Route 83 intersection; and

WHEREAS, the volume of traffic along Chester Road between American Way and State Route 83 has reduced gaps in traffic to the point that opportunities for left hand turn movements off of Chester Road have significantly diminished and become more dangerous; and

WHEREAS, the widening of Chester Road between State Route 83 and American Way to a minimum of three lanes in conjunction with provision of a formal left-hand turn into Traveler's Point will improve safety for the travelling public; and

WHEREAS, the establishment of an asphalt multi-purpose path along the north side of Chester Road between State Route 83 and American Way will improve pedestrian and bicycle safety, will serve as an extension of similar improvement on Chester Road east of State Route 83 and comports with Avon's continued efforts to enhance pedestrian connectivity; and

WHEREAS, City Council finds that it is in the best interest of the health, safety and welfare of the Community that the City Engineer go forward with advertising for public bids to complete the Chester Road Widening, State Route 83 to American Way Project during the 2019 construction season.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
AVON, COUNTY OF LORAIN AND STATE OF OHIO:**

Section 1 - That the Clerk of Council is hereby authorized and directed to advertise for public bids for the completion of public improvements within the City of Avon, to wit: improvements to be known as the Chester Road Widening, State Route 83 to American Way Project with all appurtenances thereto.

Section 2 - That the City shall reserve the right to reject any and all bids.

Section 3 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Resolution R-10-19 (Con't)

Section 4 - That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to advertise for bids for the Chester Road, State Route 83 to American Way Project in order to facilitate completion prior to the end of 2019 construction season; therefore, this resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
