**AMENDMENT  
THE CITY OF AVON  
AND  
THE CLEVELAND CLINIC FOUNDATION**

**THIS AMENDMENT**, dated as of December 14, 2020 is between the CITY OF AVON, OHIO (the "City") and THE CLEVELAND CLINIC FOUNDATION ("CCF"),

**WITNESSETH:**

**WHEREAS**, the City and CCF entered into a certain Agreement, dated on or about April 26, 2013 (the "Agreement"), under which the City authorized police officers appointed by the Cleveland Clinic Police Department to exercise police powers granted under O.R.C. §4973.17 within certain areas located in the City, subject to the limitations included in the Agreement;

**WHEREAS**, the term of this Agreement was previously extended from January 1, 2018 through December 31, 2020;

**WHEREAS**, the parties now desire to amend the Agreement to extend its term;

**NOW, THEREFORE**, in consideration of the promises herein contained and for other good and valuable consideration, the parties hereto agree as follows:

1. Section VI. of the Agreement is amended in its entirety to read as follows:

**"VI. Term**


This Agreement shall be effective after its execution under the laws of the State of Ohio and shall renew annually on December 31<sup>st</sup>. Either party may withdraw from this Agreement upon giving the other party at least thirty (30) days prior written notice of its intent to withdraw,"


2. This Amendment is effective December 31, 2020. All other terms and conditions contained in the Agreement shall remain unchanged and in full force and effect, except by necessary implication.

**IN WITNESS WHEREOF**, the duly authorized officers of the parties have executed this Amendment, as of the date indicated in the first paragraph of this Amendment.


