

ORDINANCE NO. 55-23

AN ORDINANCE AMENDING SECTIONS 1262.03, 1264.03, 1270.03, 1274.03 AND 1278.03 OF THE AVON CODIFIED ORDINANCES AS THEY PERTAIN TO FARMS AND LIVESTOCK IN THE CITY OF AVON

WHEREAS, the City of Avon is a chartered municipal corporation validly organized and existing under the Constitution and laws of the state of Ohio, and as such may regulate uses within the City; and

WHEREAS, the Codified Ordinances contain various regulations with respect to farm and livestock uses in each of the identified zoning districts and reflects the City’s acknowledgment that those uses are, under certain conditions, incompatible with adjoining permitted and special uses; and

WHEREAS, the current provisions of the Codified Ordinances dealing with farming and maintaining livestock, poultry, etc. should be harmonized with the permitted and special uses as set forth in the City’s Planning and Zoning Code to promote the full use and enjoyment of all property rights by all citizens of the community; and

WHEREAS, on April 19, 2023, by a vote of four (4) in favor and zero (0) opposed, Planning Commission recommended approval of the amendments to Sections 1262.03, 1264.03, 1270.03, 1274.03 and 1278.03 of the Planning and Zoning Code; and

WHEREAS, Council, on April 24, 2023, authorized a Public Hearing; and

WHEREAS, said Public Hearing was duly publicized according to law and was held on May 22, 2023 at 7:05 PM; and

WHEREAS, this Council believes that this ordinance will achieve the proper balance between all interests and that passage of same will promote the health, safety and welfare of all citizens of Avon. Furthermore, the existing property owners will not be denied any economically viable use of their property because this ordinance is intended to be prospectively applied; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 6 – That wherever the provisions of this Ordinance conflict with any other ordinance or any provision of the Codified Ordinances of the City, the more restrictive provision shall control.

Section 7 – That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 8 – That this Ordinance shall take effect and be in force at the earliest date allowed by law.




