

RESOLUTION NO. R-24-23

**A RESOLUTION TO RE-SCHEDULE COUNCIL'S FIRST WORK SESSION
IN THE MONTH OF JULY, 2023, CURRENTLY SCHEDULED FOR
MONDAY, JULY 3, 2023 TO MONDAY, JULY 10, 2023
AND DECLARING AN EMERGENCY**

WHEREAS, the Fourth of July holiday will be celebrated on Tuesday, July 4, 2023; and

WHEREAS, to avoid conflicting with vacation and/or personal holiday plans of the general public, members of Council, and city officials, Council deems it advisable to amend Avon Codified Ordinance Section 220.01 to move the first Work Session of Council for the month of July, 2023 from Monday, July 3, 2023 to Monday, July 10, 2023 at 6:30 p.m., one hour prior to Council's regular meeting at 7:30 p.m.

WHEREAS, Council deems it in the best interest of the health, safety, and welfare of the citizens of the City of Avon that Council's July 3, 2023 be rescheduled.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
AVON, COUNTY OF LORAIN AND STATE OF OHIO:**

Section 1 - That the Avon City Council hereby amends Avon Codified Ordinance 220.01 (also known as "Council Rules") and will reschedule the first work session in the month of July, 2023 from Monday, July 3, 2023 to Monday, July 10, 2023 at 6:30 p.m.. Council's regular meeting, scheduled for July 10, 2023 at 7:30 p.m. will begin immediately following the conclusion of said work session. This amendment applies only to the month of July, 2023.

Section 2 - That it is found and determined that all formal actions of the Council of the City of Avon concerning and relating to the adoption of this Resolution were taken in an open meeting of the Council of the City of Avon and that all deliberations of this City's Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

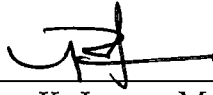
Section 3 - That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity to amend Council Rules to reschedule the first work session of Council in the month of July, 2023 from Monday, July 3, 2023 to Monday, July 10, 2023 at 6:30 p.m.; therefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.

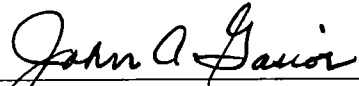

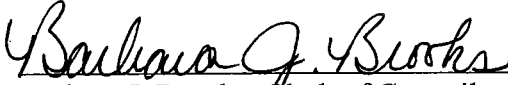

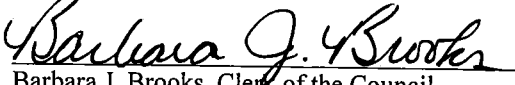
